#### **Directions**

This product should be dispensed only from equipment designed specifically to handle solid capsule products. Your service technician will set your concentration to yield proper results. Wash temperature should be at least 140-150°F (60-68°C) Change water when noticeably dirty. For proper sanitizing in hot temp applications, rinse water should be maintained at 180-190°F (82-90°C). In low temp applications, this product is compatible with chlorine sanitizers.
